Re: Response to Division Order: Correct Permit Areas for PacifiCorp Mines, PacifiCorp, Trail Mountain Mine, ACT/015/009 - DO-2000A, Des-Bee-Dove, ACT/015/017 - DO-2000A, Deer Creek Mine, ACT/015/018 - DO-2000A, Cottonwood Mine, ACT/015/019- DO-2000A, Emery County, Utah.

PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits a response to the Division Order to correct permit areas for PacifiCorp mines in Emery County.

Division Order:

Provide an accurate legal description of the land with the permit area and surface disturbance area in accordance with:

R645-301-111.200 Responsibility. It is the responsibility of the permit applicant to provide to the Division all of the information required by R645-301-100.

R645-301-114 Right-of-Entry Information.

114.100. An application will contain a description of the documents upon which the applicant bases their legal right to enter and begin coal mining and reclamation operations in the permit area and will state whether that right is the subject of pending litigation. The description will identify the documents by type and date of execution, identify the specific lands to which the document pertains, and explain the legal rights claimed by the applicant.

114.200. Where the private mineral estate to be mined has been severed from the private surface estate, an applicant will also submit:

114.210. A copy of the written consent of the surface owner for the extraction of coal by certain coal mining and reclamation operations;

114.220. A copy of the conveyance that expressly grants or reserves the right to extract coal by certain coal mining and reclamation operations; or 114.230. If the conveyance does not expressly grant the right to extract the coal by certain coal mining and reclamation operations, documentation that under applicable Utah law, the applicant has the legal authority to extract the coal by those operations.

114.300. Nothing given under R645-301-114.100 through R645-301-114.200 will be construed to provide the Division with the authority to adjudicate property rights disputes.

R645-301-140 Maps and Plans

R645-301-521.121 The location of all buildings in and within 1000 feet of the proposed permit area, with identification of the current use of the buildings

R645-301-521.140 Mine Maps and Permit Area Maps. These maps and/or cross-section drawings will clearly indicate

R645-301-521-141 The boundaries of all areas proposed to be affected over the estimated total life of the coal mining and reclamation operations, with a description of size, sequence and timing of the mining of subareas for which it is anticipated that additional permits will be sought; the coal mining and reclamation operations to be conducted, the lands to be affected throughout the operation, and any change in a facility or feature to be caused by the proposed operations.

The Division Order requiring a specific legal description for the mining operations listed is not warranted by the regulator. In a review of the sited regulations, a legal description of the permit area is not required. The lack of specific regulation requiring a legal description was also confirmed during a telephone conversation with Mary Ann Wright on March 8, 2000. During the discussion with Ms. Wright, PacifiCorp explained the difficult situation of providing a legal description for mining operations located on East Mountain (Cottonwood/Wilberg, Deer Creek and Des-Bee-Dove mines) as the result of Federal Coal Lease relinquishments which have been accepted in part by BLM. To comply with the Division Order, PacifiCorp recommended submitting amendments to clarify and accurately depict the "permit area" for each of the East Mountain property mines. Ms. Wright indicated that the Division did not want PacifiCorp to submit amendments revising the "permit area", instead, she simply wanted PacifiCorp to provide the Division with a description which describes the boundary of each of the identified permits.

The currently approved permits include a map which outlines the "permit area". Within each permit package, PacifiCorp legally describes the "permit area". Listed below is a revised legal description for each of the mines sited in the Division Order:


