Then the UPDES site 001 for Deer Creek, CTE # 59-23783 from February of 2002 (which is on the missing sample list, unless I screwed up again which is not unheard of) has an error I have never seen before and I honestly have no idea what it means, it says: Error- NON-calculated Lab and Lab ID duplicated in EDI- "Delete One". If you could let me know that would be fantastic.

Next I need I new site for Cottonwood (mine #2) for a post mining series of samples we are doing for the Forest Service. It's in Miller canyon but it isn't the UPDES discharge point, so a new site number is requested. Then, I apologize for the inconvenience, but two samples you just uploaded to the Miller Canyon Outfall (Cottonwood, mine number 2, site number 7) need to be moved to the new site.
