**1. Permits, Change, Transfer, Renewal, Sale**

The Cottonwood/Wilberg site is currently inactive. There are no plans to activate the mine.

**4.d Hydrologic Balance: Water Monitoring**

The undersigned and Division Hydrologist, Jim Smith, reviewed the third quarter and some of the fourth quarter data for the mine. Hard copies of the data are kept in two notebooks one for site data and one for U.P.D.E.S. data. Electronic data input was current up to and including the third quarter data of 2003. Volumes 9 and 9a of the MRP contain the monitoring requirements, parameters, and site location maps for the mine. Mr. Semborski indicated that a number of sites contained enough data to complete trend analysis as supported by two independent studies that were provided to the Division. It was suggested that an amendment referencing the studies and identifying the reduction or elimination of the monitoring parameters or site locations be submitted.
