1. Permits, Change, Transfer, Renewal, Sale

The application for permit renewal was received at the Division's Salt Lake Office on May 10, 2004. An inspection of records for the Cottonwood mine indicated that the permittee had published in the Sun Advocate a notice to renew the permit for the Cottonwood/Wilberg mine. However, the information required to renew the permit was received by the Division 65 days after the due date of March 6, 2004. Notice of Violation # N04-1-1-1 was issued for failure to submit an application for permit renewal 120 days prior to permit expiration. This inspection was conducted in accordance with the requirements of R645-400-322.
