PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits an amendment to Volume 1 Part 1 Legal & Financial Compliance section of the Cottonwood/Wilberg Mine permit. On May 12, 2003, Energy West submitted a supplemental volume entitled "Supplemental Volume, Legal and Financial Information" to the Division. This new volume included legal, financial, ownership, and control information for PacifiCorp's four coal mines in Emery County, Utah. This volume was approved by the Division May 20, 2003. Prior to the approval of this volume, legal, financial, ownership, and control information was contained in each of the four permits. Much of the information (i.e. control information) is repeated in each permit. Combining this information into one volume will make updates easier and less confusing to process for both the Division and the permittee.

As documented on the C1/C2 forms (see attachment) of the May 12, 2003 amendment to include the Supplemental Volume, Energy West requested that the Division remove Volume 1 Part 1 in entirety. Energy West neglected to include reference sheet to be inserted in Part 1 to indicate the revised location of the approved legal & financial information. To correct this situation, Energy West has included a reference sheet to be inserted in Volume 1 Part 1.




