I inspected and walk the main diversion. It is stable and would function during a rainstorm. There was no water flow that could be seen. Maybe some water could be flowing under the large boulders.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclaim area is completely pock. The water is within these pocks and prevents water going of site. See Photos

8. Noncoal Waste

The site was clean of non-coal waste materials such as trash, oil cans, wood and scrap materials.

10. Slides and Other Damage

No slides or other damage was notice during the inspection.

The reclamation site is completely backfilled and graded.
