4.a Hydrologic Balance: Diversions

I inspected and walk the main diversion. It is stable and would function during a rainstorm. There was no water flow.

4.c Hydrologic Balance: Other Sediment Control Measures

The mine site was completely pock. Water is retained within the pocks. I did not see any runoff leaving the disturb area.

8. Noncoal Waste

There is non-coal waste material/trash that needs to be pick-up.

10. Slides and Other Damage

The reclamation sites appear to be stable. No slides or other damage was notice during the inspection.

12. Backfilling And Grading

The reclamation site is completely backfilled and graded. It is in my judgement the site meets AOC.

13. Revegetation

Grasses are coming up in the pocks.
