4.a Hydrologic Balance: Diversions

It was raining and the main diversion was not flowing water. The diversion was intact. It will take a major rainstorm or snow melt to see water flow.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclaim area is completely pock. The water is within these pocks and prevents water going off site.

8. Noncoal Waste

There is non-coal waste material/trash that needs to be pick-up.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection. The reclamation site appears to be stable.

12. Backfilling And Grading

The reclamation site is completely backfilled and graded.

13. Revegetation

Vegetation such as grasses are coming up in the pocks. See photos
