In view of the status of the six stipulations send to Co-op Mining Company on March 12, 1980, and agreed upon by yourself on March 31, 1980, the Division cannot grant approval of any mining activity at the Bear Creek Canyon Portal area until these six stipulations have been met. The interim regulatory final approval letter issued March 20, 1981, was granted to Co-op Mining Company to allow for completion of the six stipulations agreed upon by Co-op Mining Company on March 12, 1980. Once the six stipulations have been completed, the Bear Creek Canyon Portal area will be inspected to determine whether or not mining activities may proceed. However, at this time, no mining activities may proceed until these six stipulations are met.
