8. NONCOAL WASTE

The permittee is having difficulty getting noncoal waste containers hauled off-site. One long roll-off style dumpster was observed on the Hiawatha intake portal material pad; this dumpster was over capacity. Two smaller mine material trailers were also observed heavily loaded with empty rock dust bags. The area did not present a problem regarding noncoal waste.

20. AIR QUALITY PERMIT

Mr. Petersen informed me that the Utah Division of Air Quality had been on site the previous day. According to him, no problems had been observed by that agency.
