2. Signs and Markers

The mine ID sign is located at the point of public access. Parts of the sign are missing (ie, part of the phone number). The sign is legible, but dated.

4.a Hydrologic Balance: Diversions

A belt roller is in the main portal access road diversion. The roller needs to be removed from the diversion.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Several sediment ponds that are nearing the 60% clean elevation are slated to be cleaned this year. A map representing the as-built conditions of pond D is being prepared and will be submitted to the Division.

8. Noncoal Waste

Oil can adjacent to load out by main portal access road entrance needs to be collected and placed in the approved noncoal waste storage area.
