2. Signs and Markers

The mine identification is in place at the point of public access to the mine permit area.

4.a Hydrologic Balance: Diversions

Maintenance work has taken place on several diversions along the portal access road.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Cleaning of pond D has resumed. The pond is approximately 60% clean.

Silt fence around the stream buffer zone by the entrance into the bath house area needs maintenance.
