2. Signs and Markers

Mine identification sign is located on a fence at the point of public access to the permit area.

4.a Hydrologic Balance: Diversions

The majority of the diversions and culvert inlets and outlets have been recently maintained and cleaned following the recent storm events. A few diversions are still being worked on to remove rock and debris, but are still compliant with their approved design found in the Mining and Reclamation Plan (MRP).

4.c Hydrologic Balance: Other Sediment Control Measures

Some water is present in the sedimentation ponds from recent rain storm events.

5. Explosives

Explosives have been removed from the site. Magazines for caps and powder are still present along side of the access road to the portal area. The magazines are properly identified and grounded according to regulation.
