2. Signs and Markers

The Mine identification sign is in place at a point of access from the county road into the permit area. The sign contains all of the required information.

4.a Hydrologic Balance: Diversions

Culvert inlet located above the lump coal storage is partially smashed. The top of the culvert should be raised back into position. Berms around the inlet need to be raised to ensure that the flow does not bypass the inlet.
