## **2. Signs and Markers**

The mine identification sign is located at the entrance into the mine site permit boundary. The sign had the following information listed: The name of the mine, mailing address, telephone, and the Utah mining permit number. The sign is in compliance with the requirements of the Utah Coal Rules.

### **4.a Hydrologic Balance: Diversions**

The snow cover within the diversions is beginning to melt. The diversions appear to be functional with the warmer temperatures. Once the snow melt is finished the diversions will be re-evaluated during a Division inspection to make sure that they are completely functional.

## **5. Explosives**

The powder and cap magazines are properly grounded against a lightning strike. The signs are properly placed to prevent damage to the magazines in the event that a bullet was shot at the sign.

## **8. Noncoal Waste**

Piles of noncoal waste were observed in the bath house parking area and adjacent to the noncoal waste dumpsters. The items need to be gathered and placed in the approved noncoal waste receptacles.
