**2. Signs and Markers**

The mine ID sign located at the permit boundary was observed when entering the mine permit area. The sign contains the name, address, phone number and Utah Mining Permit number as required by law. The sign was found to be in compliance with the Utah R645 Coal Rules.

**4.a Hydrologic Balance: Diversions**

The diversions through-out the mine site were found to be open, well graded and functional

**5. Explosives**

The powder and cap magazines were observed as part of the partial inspection. The magazines are not placed in close proximity, but are separated by a large distance. Both magazines are labeled and grounded.

**8. Noncoal Waste**

The mine site was well maintained. Transient noncoal waste is being controlled and stored in the approved storage vessel's.
