

- SPCC Plan dated January 2011. The Plan is P.E. certified, stamped, signed and dated by a Utah P.E on 01/25/2011.

2. Signs and Markers

The mine identification sign is located at the entrance into the mining permit area. The sign is posted on a gate and contains the information requires and set forth by the Utah R645 Coal Rules. The sign is in compliance with the regulations.
