2. Signs and Markers

The mine identification sign for the Bear Canyon Mine is posted on a gate at the entrance into the mining permit area. The sign contains the required information set forth in the Utah R645 Coal Mining Rules. The sign is in compliance with these rules.

4.a Hydrologic Balance: Diversions

The road diversions leading to the main portal access were observed. Some areas have slumped dirt and/or rock. These items have not impeded the drainage pattern and will be removed or realigned the next time the road is graded.

5. Explosives

Powder and cap magazines are not located in close proximity to each other. They are signed and grounded in accordance with regulations.
