**2. Signs and Markers**

The mine identification sign is located at the entrance into the mining permit area. The mine was checked to ensure that it had the necessary information to be compliant with the Utah R645 Coal Rules.

**4.a Hydrologic Balance: Diversions**

A piece of blue PVC pipe had come off a supply trailer and was laying in the road diversion ditch that leads to the portal area. The PVC pipe was removed from the diversion during the inspection.

**5. Explosives**

The powder and cap magazines were inspected. They are separated by a substantial distance from each other. Both magazines are signed indicating explosives and are properly grounded in case of a lightning strike.

**8. Noncoal Waste**

Noncoal waste is being stored in the approved storage containers.
