4.a Hydrologic Balance: Diversions

Recent high volume thunder storms have impacted numerous diversions. Work on several of these diversion has already been taken or is underway. In several locations the material has been removed from the diversions and stacked. This material still needs to be gathered and hauled off. Sediment Pond B was also impacted and is currently being cleaned.
