2. Signs and Markers

The mine identification sign was observed upon entrance into the mining permit area. The sign contained the required information.

4.a Hydrologic Balance: Diversions

The diversion adjacent to the weigh scale house needs some maintenance work. The diversion is still functional but needs cleaning.

Several locations along the portal access road needs maintenance. Mainly with treatment structures (Straw Bales). Work has already been done on a few locations, but at least two still need attention.

5. Explosives

Powder and cap magazines were observed. They both are signed and grounded.
