The material located along the access road to the active portals was not topsoil as noted in the previous inspection, it was road base material that would not hold up in muddy conditions and was excavated to provide a more functional road base material during the previous year.

The approved revegetation success standards revision (January 9) will provide the permittee the opportunity to apply for phase three bond release on the tank seam road this year (2015).
