

1. Permits, Change, Transfer, Renewal, Sale

The 5 year permit renewal for the mine was completed effective 11/2/2015 and expires 11/2/2020. There are currently no permitting actions on file with the Division. However DOGM is waiting for OSM concurrence on the tank seam road phase III bond release application. DOGM will need to finalize the review of the 2015 vegetation survey of the road. If the survey data meets the success standards OSM will most likely concur with the Division's recommendation to grant phase three bond release for this area.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond B appeared to be stable and showed no signs of erosion on the reinforced inlet.
