
Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

3. Topsoil

The berm had not been placed around the topsoil stockpile.

4.a Hydrologic Balance: Diversions

The berm along the access road to the BTCA area needed to be built up higher to adequately transport runoff to it.

18. Support Facilities, Utility Installations

The vacuum truck was not operational at the time of the inspection. It appeared as though the pans had been cleaned out along the beltline near the transfer point above the topsoil stockpile.
