Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

The purpose of this site visit was to visit the approximate location of a proposed breakout in the Bear Canyon coal seam in the Left fork of Fish Creek canyon. On Tuesday, August 16th, Joe Helfrich and Jaren Jorgensen met with Karl Boyer (Geologist) from the Manti La-Sal National Forest to discuss the conceptual plans for the proposed breakout. On Wednesday, August 17th, Joe and Jaren drove to the head of the Left fork of Fish Creek canyon and hiked downslope on the South side of the canyon to a rock outcrop across the canyon from the proposed breakout location. Photographs of the area were taken and provided to Charmaine Thompson (Archaeologist Manti La-Sal National Forest) and Karl Boyer. They are included in this report.

1. Permits, Change, Transfer, Renewal, Sale

Current mining conditions at the Bear Canyon mine may necessitate additional ventilation sometime in the next year as such Castle Valley Mining is contemplating submitting an amendment to develop a breakout from inside the mine in the Bear Canyon coal seam. The breakout will provide the additional air flow required to properly ventilate the mine.

9. Protection of Fish, Wildlife and Related Environmental Issues

There are four Golden eagle nests (#'s 901, 2, 3 and 4) located at the upper end of the Left fork of Fish Creek canyon one of which (#903) was active in 2015. Preliminary mapping locations indicate that the nests are greater than 1/2 mile from the proposed breakout area. DOGM will consult with DWR and USFWS when the amendment is submitted to the Division.
