**1. Permits, Change, Transfer, Renewal, Sale**

An extension to April 18th has been granted for the submittal of the 2017 annual report.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The inlet to sediment pond B was in good shape. There was some water in the lower end of the pond at the 100% sediment level on the decant pipe. The upper end was mostly exposed sediment indicating that the pond will need to be cleaned. This is usually done in conjunction with the annual cleaning of the other three ponds when the sediment dries out and is manageable in mid to late summer.

**9. Protection of Fish, Wildlife and Related Environmental Issues**

Rhino enregy has scheduled a ground survey for tree nesting raptors this spring.

**16.b Roads: Drainage Controls**

The drainage controls for the access road to the #4 mine were inspected. The road itself is nearly dried out and has been graded. There are several culvert inlets that were still snow and ice filled. The extra check dam for the upper ASCA should be reinforced. The diversion ditch along the inside of the road was in good repair.
