1. Permits, Change, Transfer, Renewal, Sale

The permittee will be submitting an amendment for belt line coal falling on the ground by the next inspection.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

I inspected the topsoil piles and I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm.

4.a Hydrologic Balance: Diversions

The diversion at the truck-turn a-round has sediment on the outlet end. Maintenance is needed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were not discharging and contain little to no water. The embankments were stable. The inlets and outlets would function as design. No hazardous conditions were notice.

8. Noncoal Waste

The site was clean of non-coal waste materials such as trash, oil cans, wood and scrap materials.

16.a Roads: Construction, Maintenance, Surfacing

Roads to the mine are well compacted and been graded.

16.b Roads: Drainage Controls

I inspected the road diversions and culverts throughout the property. They were functioning as design. See Photos
