The Utah Division of Oil, Gas and Mining has completed a cursory review of the Mining and Reclamation Plan (MRP) and amendments submitted by Genwal Coal Company, Inc., for their Crandall Canyon Mine. This Division has determined the plan to be apparently complete. In compliance with Section UMC 786.11(b) and (c) of the Utah Coal Mining Reclamation Act (UCA, Section 40-10-1 et seq), notice is hereby given to all appropriate agencies having jurisdiction over or an interest in the area of the proposed operations that a complete plan is available for public review for this proposed operation.

The Crandall Canyon Mine is located in the general vicinity of the past surface disturbance of the prior mining activities conducted as the Tip-Top Mine owned by John F. Sanders. The approximate location is approximately one and one quarter miles upstream from the confluence of Crandall Creek with Huntington Creek. The permit area is located on the Rilda Canyon U. S. Geological Survey 7.5 minute quadrangle map.

The coal mining operation's total surface disturbance is estimated to be approximately 10.4 acres.

Genwal Coal Company proposed Crandall Canyon Mine will involve surface facilities and the underground mining of coal. The proposed permit area contains the following areas:


