Dear Daron:

Enclosed is Genwal Coal Company's ("Genwal's") revised Application for Transfer of the Crandall Canyon Mine Permit ACT/015/032. The Application has been revised consistent with the recommendations set forth in the Division's letter of November 23, 1993 as follows:

- Page 1 has been revised to state that the Crandall Canyon Mine is located in Emery County, Utah.
- Page 2 has been revised to identify Larry W. Johnson as the resident agent for service.
- Pages 4 and 5 have been revised to show the dates that positions were assumed by officers and directors of Intermountain Power Agency ("IPA").
- Page 5 has also been revised to reference a new Plate 1-1 replacing Plates 2-1 and 2-2. Three copies of Plate 1-1 are enclosed.
- Page 6 has been revised to reflect Mountain Coal Company's leasehold interest.

- Page 7 has been revised to show Genwal's and Mountain Coal Company's leasehold interest in surface operations or facilities. In addition, page 7 is modified to show state and federal leasehold interests. Finally, MSHA numbers and employee identification numbers have been provided for the Crandall Canyon Mine, Wellington Loadout and the Horse Canyon Mine.
- Page 8 has been revised to reflect Genwal's pending federal lease application on contiguous lands.
- Page 9 has been revised to address underground access with respect to Mountain Coal Company's property.
- Page 10 has been revised to correct the newspaper advertisement. Notice of this transfer was published initially on November 9, 1993 and proof of publication has been filed with the Division. Although this amended notice was published on December 7, 1993, it is our understanding that the notice published on November 9, 1993 was adequate to satisfy that 30-day publication requirement.

The current verification and execution page set forth at pages 10 through 11 of the existing application are adequate and will be retained.

We have reviewed the surety rider dated September 7, 1993 executed by Genwal with respect to Bond No. 4689175. This rider has been signed by Denise Wood as Treasurer of Genwal and is correct as currently stated. Therefore, it would appear that execution of a new surety rider may not be necessary.
