4.a Hydrologic Balance: Diversions

The diversions were found to be in compliance with the regulations. Two diversions are starting to accumulate sediment that could present a problem in the future. The diversions are adjacent to the access road at the start of the disturbed area to the mine site and the diversion located immediately behind the crusher building.
