1. Permits, Change, Transfer, Renewal, Sale

The midterm permit review has been completed and approved.

2. Signs and Markers

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign contains the name, permit ID #, address, and phone number of the operator. All other signs and markers observed during the inspection met the coal rules.

3. Topsoil

A portion of the silt fence around the topsoil pile at the entrance to the USFS access road has collapsed. The silt fence needs to be maintained.

4.a Hydrologic Balance: Diversions

The diversion above the oil storage area contains noncoal waste items. Noncoal waste items are located on the slope above the diversion previous mentioned.

The culvert inlet at the mine permit entrance has been cleaned.

The culvert outlet from the coal storage pad that empties into the diversion behind the crusher building needs to be monitored to see if the material in front of the outlet is ice or if there is enough sediment to necessitate cleaning.

4.d Hydrologic Balance: Water Monitoring

Fourth quarter 2006 water monitoring is in the EDI website and has been uploaded. Water monitoring is current.

8. Noncoal Waste

The mine site in general looks better than on the previous inspection. However, noncoal waste items are still present in the diversion above the oil storage area and on the slope above the diversion.
