2. Signs and Markers

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign contains the name, permit ID #, address, and phone number of the operator. All other signs and markers observed during the inspection met the coal rules.

3. Topsoil

Several thistle plants were noted on the topsoil pile adjacent to the beginning of the USFS service road. The thistle is present in the area where the new material was placed on the topsoil pile from the USFS Trail Head/Parking area. Actions need to be taken to prevent the thistle from spreading and to eliminate it from the topsoil pile.

4.a Hydrologic Balance: Diversions

The diversion behind the crusher building (concrete diversion) is starting to accumulate coal material. The diversion is still in compliance, The diversion was cleaned approximately 2 months ago and is starting to build up again. There have been no notable storm events, therefore the accumulation must be tied to operational activities. The permittee should monitor this area to assure that the diversion remains functional.

4.d Hydrologic Balance: Water Monitoring

First quarter 2007 water monitoring is in the EDI website, but has not been uploaded. Water monitoring is current.

8. Noncoal Waste

There were a few noncoal items outside of the designated storage facility, but the site showed a marked improvement from prior inspections.
