2. Signs and Markers

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign contains the name, permit ID #, address, and phone number of the operator. All other signs and markers observed during the inspection met the coal rules.

22. Other

The North Portals have temporary seals installed and the north ventilation fan and pumps have been de-energized. Presently the south portals are still open and the south ventilation fan is still operational. The majority of the supplies and equipment have been removed from the mine site. The coal stock pile has been shipped. A small amount of coal remains on the coal pad floor and adjacent hillside. No coal trucks were present during the inspection. The remaining coal on the stock pile floor and adjacent hillside bank will remain during the period of time that the mine is idled.
