18. Support Facilities, Utility Installations

Snow removal from the upper storage pad was taking place during the inspection. The snow is being removed and placed on the coal pile storage pad. The snow removal activity will allow access for construction activities to take place incident to construction of a memorial for the five Miners who were not recovered and the three rescuers who lost their life in the recovery effort. The upper portion of the upper storage yard will allow parking. This area will eventually require a post mining land use change to allow the parking area to remain after final reclamation. The remainder of the memorial will be constructed outside of the jurisdiction of the Division.
