**2. Signs and Markers**

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign contains the name, permit ID #, address, and phone number of the operator. All other signs and markers observed during the inspection met the coal rules.

**3. Topsoil**

The silt fences around the topsoil piles just above the bridge and the silt fence next to the topsoil pile by the truck turnout are in need of maintenance and repair.

**4.a Hydrologic Balance: Diversions**

The culvert inlets by the main permit entrance and inlet adjacent to the oil storage building need to be cleaned.

**5. Explosives**

Explosives have been removed. The explosive storage units have been moved from there original location incident to the construction of the miners memorial. The storage units on the storage pad area, but are non functional.
