

2. Signs and Markers

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign needs to be replaced. The information is no longer accurate. The mailing address has changed.

4.a Hydrologic Balance: Diversions

There are two culvert inlets that need maintenance work. The first is the inlet on the up-canyon side of the oil storage building. The second inlet is just above the noncoal storage area against the concrete retaining wall.

4.d Hydrologic Balance: Water Monitoring

First quarter 2008 water monitoring information is in the EDI website and has been uploaded. Water monitoring is current.
