Viewed the north portal area mine water collection system and discussed the installation and operational function and potential reclaimed function of this system.

22. Other

Viewed the reclaimed emergency drill hole pads. The reclamation of the pads and pad roads is completed. The main access road is still open and will be open until next year so that a determination can be made as to the success and stability of the reclamation work that was accomplished in 2008. The reclamation of the steep pad areas and pad roads appears to have been laid back in place to conform with the natural slopes in this area. The reclaimed area has been pocked with holes to help retain moisture. The area has been seeded.
