2. Signs and Markers

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign contains the name, permit ID #, address, and phone number of the operator. All other signs and markers observed during the inspection met the coal rules.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The water elevation in the sediment pond is at the oil skimmer. The water elevation needs to be lowered to ensure enough capacity for storm events and/or winter conditions. The company made arrangements to begin pumping the water level down and to use it for dust suppression.

The excess water was deposited in the sediment pond from the surface flow out of the North Portals during the summer, but the water never evaporated as anticipated and other storm events have led to the current level.
