2. Signs and Markers

The Mine ID sign is posted at the entrance to the permit area from the forest service road. The sign contains the name, permit ID #, address, and phone number of the operator. All other signs and markers observed during the inspection met the coal rules.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The pond to treat the mine water for the iron problem is almost completed. The liner was being installed in the pond during the inspection.

The sediment pond cleaning began today. A long stick hoe and dump truck were on site. The pond cleaning material is being hauled onto the coal storage pad and then placed behind a berm to help settle and filter the material.
