RE: Revised Stipulation -- Compliance Schedule, Crandall Canyon Mine, Permit C/015/0032, DO 10A, dated August 16, 2010, and Task ID #3582, dated July 15, 2010

Dear Mr. Alder:

On behalf of Genwal Resources, Inc. (“**Genwal**”), this letter amends our Stipulated Agreement to Extension of Time Regarding Division Order DO10A, dated September 14, 2010, attached. The Division and Genwal, through their counsel of record, agree that compliance with Paragraph IV of the Division Order (“**DO**”) is extended from October 31, 2010, to November 30, 2010. By that date, in compliance with DO Paragraph IV.1, Genwal agrees to submit to the Division an amendment to the Mining and Reclamation Plan (“**MRP**”) to reflect the current “operational” treatment measures and facilities associated with the mine water discharge, including all aspects of the current treatment process with associated costs and as-built drawings. In compliance with DO Paragraph IV.2, Genwal will submit to the Division a revised probable hydrologic consequences (“**PHC**”) determination amending the MRP to reflect current conditions for the Crandall Canyon Mine.

The parties further agree that Genwal’s submittal in response to DO Paragraphs IV.1 and IV.2. is responsive to Paragraph 1, bullet items 2 and 5 of the requirements of Task ID #3582 set forth in the Division’s letter dated July 15, 2010, as amended November 1, 2010. The time for compliance with additional informational requests to address Task ID #3582 is extended until December 15, 2010.
