

2. Signs and Markers

The mine identification sign is located at the point of public access to the permit area.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond interior has been groomed since the recent cleaning. Two sediment markers have been installed in addition to a marker to depict the level that the experiment iron sludge placement from the iron treatment facility can reach inside of the sediment pond as the iron treatment facility is cleaned.

Minor noncoal waste along access road to site within the permit area.

MSHA was on site conducting their inspection of the South Portals. The fan to the South Portals had been started and access into the South Portals was evident from the chain link fence being lifted thereby allowing entrance.
