2. Signs and Markers

The mine identification sign is located at the point of public access to the permit area. The sign contains the required information.

4.a Hydrologic Balance: Diversions

The diversions on site are all snow covered.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The Operator/Permittee has committed to installing a marker in the sediment pond to identify the maximum level of iron laden water that could be diverted into the sediment pond in case of an emergency bypass. The marker was not in place on this inspection. If the marker is not installed by the next inspection enforcement action may be taken.

7. Coal Mine Waste, Refuse Piles, Impoundments

Workers were on site working on the baffle system within the iron treatment pond.

16.a Roads: Construction, Maintenance, Surfacing

The main access road to the mine site has been plowed to allow access to the mine site.
