2. Signs and Markers

The mine identification sign is located at the point of public access to the permit area. The sign contains the required information.

4.a Hydrologic Balance: Diversions

Checked several diversions and culvert inlets and outlets. All were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Small amount of water in base of sediment pond from melting conditions.

4.c Hydrologic Balance: Other Sediment Control Measures

Maintenance work is required on siltation structures around the topsoil pile at the beginning of the USFS access road to the mine. The referenced pile is on the left side as you are traveling to the mine site.
