

2. Signs and Markers

The mine identification sign is located at the entrance into the mine site from the forest Service road. The sign is positioned at the permit entrance and contains the required information.

4.a Hydrologic Balance: Diversions

Care needs to be taken not to allow plowed snow to enter the diversions. A minor amount has rolled into the diversions, but not enough to prevent melting and flow. Future snow plowing should allow enough space away from the diversion to prevent an impact or covering of the diversion.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Pond surface is frozen and snow covered.
