## **2. Signs and Markers**

The mine identification sign is posted at the being into the Main Mine Site and also at the permit entrance into the Main Mine Site. The sign was checked and found to be in compliance with the requirements found in the regulations.

Observed topsoil pile signs on the various topsoil piles down canyon.

### **4.a Hydrologic Balance: Diversions**

Some diversions on site are still snow covered and will be checked after the snow melt. The diversions that were melted are functional, including inlets and outlets of culverts.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The pond level appeared to be about 6- 8 inches below the Marker used to identified when the pond need to be pumped down in order to maintain the proper amount of free board for the designed storm event, since the pond has been allowed to be used on a temporary basis as a storage for the iron treatment pond cleanings.

### **4.c Hydrologic Balance: Other Sediment Control Measures**

The wattles around the several topsoil piles were observed and appeared still functional.

The main mine site area was found to be free of noncoal waste items.
