2. Signs and Markers

The mine identification sign is in place at the main entrance into the permit area. The sign contains the required information.

4.a Hydrologic Balance: Diversions

All diversions, ditches, inlets and outlets were observed. All diversions were found to be fully functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Observed the sediment pond and took several pictures. The pond water and sediment s is stained orange/red from the water and sediments placed in the pond from the iron treatment pond cleanings. This process has been allowed on a temporary basis until the operator/permittee can permit a new facility designed for this purpose.

The iron treatment pond was observed and a picture was taken. The pond and treatment facility was functional during the inspection and appeared to be dropping the iron sediments as designed due to the clarity of the water in the pond toward the discharge point and clarity of the discharge water itself.

8. Noncoal Waste


Mine site was found to be free of transient noncoal waste.




