2. Signs and Markers

The identification sign was checked and meets the minimum requirements of the R645 Coal Rules.

4.a Hydrologic Balance: Diversions

Diversions and culverts were inspected and no obstructions were observed. They were open and appeared to be functioning as designed. No water was flowing within the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was not ice covered. The pond did contain water but was not discharging during the inspection. I did not see any hazardous conditions during the inspection. The embankments appear to be stable.

4.e Hydrologic Balance: Effluent Limitations

The permittee was in the process of replacing the Coagulant pump. The pump had failed in the early morning hours. The permittee was also in the process of cleaning out cell #2 in the iron reducing pond. The permittee and I took a field sample of iron on the discharge end of the pond. The results were .2 mg/l of iron. This is below the maximum amount of 1.24 mg/l allowable limit. It is customary that the Division and the permittee take joint water samples. Due to the repair work and low iron discharge, no water samples were taken. The Division management has notified me to make a special trip this month to the mine and take water samples.

8. Noncoal Waste

The site was clear of non-coal waste materials.
