The purpose of the hearing is to allow the Board to receive testimony and evidence regarding the issues listed below for Agency consideration that the Board shall consider:

1. Denying the application for a mining permit for the C Hollow Mine, at Alford, Utah, and
2. Requiring that Applicant use its own life and equipment under the circumstances.

Persons interested to object to the proposed Agency Action and the proposed hearing date should file a written request with the Board prior to the hearing date. The Board will consider all written requests to participate as a party to the Board Hearing.

Natural persons may appear and represent themselves before the Board. All other representation by parties before the Board will be by attorneys licensed to practice law in the State of Utah, or attorneys licensed to practice law in another jurisdiction which must be admitted to the Utah State Bar or practicing law before the Utah courts.

Persons interested in this matter may participate pursuant to the procedural rules of the Board. The Rules for Agency Action, and any subsequent amendments may be inspected at the office of the undersigned.
