A sign has been posted at the north access to the mine site with the requisite information.

Topsoil from the Robinson creek buffer area needed to be stockpiled.

The Robinson Creek diversion has been completed

**6. Disposal of Excess Spoil, Fills, Benches**

More of the coal seam has been exposed to identify the outcrop. No coal has been loaded or shipped to date. An application was received on February 7th to revise the mining sequence and spoil placement of pits 1 through 8 which will save additional spoil handling.

**9. Protection of Fish, Wildlife and Related Environmental Issues**

The lek was visited no birds were seen as of the date of this inspection. It will take approximately 21/2 years of mining before the lek is mined through.
