NOV's 10079 and 10084 can be terminated. Wildlife commitments are being evaluated for compliance with the permit and regulations. According to information provided by Rhett Boswell ACD does not intend to develop a connectivity corridor. ACD has not contacted the DWR big game biologist (Dustin Schaible) to present critical migration information to ACD employees. Big game migration activities have resulted in two personal injury accidents to date. ACD has not responded to the Division's request to provide an update on the sage grouse monitoring commitment.



4.e Hydrologic Balance: Effluent Limitations

NOV 10084 can be terminated. The unauthorized discharge has ceased, been reported to DEQ and apparently cc'd to Kevin Lundmark. There is water behind the temporary dike that is periodically pumped into a truck and taken to pond #1 or used for dust suppression on the coal stockpile according to Kirk Nicholes.
